<ul> <li>Permission to Publish:</li> <li>The school newsletter, website and Facebook page provide opportunities to share the achievement of our students. Class Dojo is used to share information within individual classes; to do this, the school needs permission to publish.</li> <li>The school or Department of Education may publish information about students for the purposes of sharing experiences with other students and the broader community. Such information may include your child's name, age, class and information collected by the school such as photographs, sound and visual recordings, your child's work and interactive media. The school Facebook page does not include student names. If a name is required, express permission would be sought.</li> <li>The communications in which your child's information may be published include but are not limited to:</li> <li>Public websites of the Department including the school website, the Department's intranet (staff only), blogs and wikis.</li> <li>Departmental publications including the school newsletter, annual school magazine, school report and promotional material published in print and electronically including Department websites.
